

GATEWAY BOWLING CLUB MEMBERSHIP

TERMS & CONDITIONS

These Terms & Conditions are current at 1st September 2011.

1. Membership

1.1. Gateway Bowling Club Membership is operated by Gateway Leisureplex, Attycunnane, Belmullet, Co. Mayo. Senior Membership of the Gateway Bowling Club is only available to eligible individuals aged 17 years or over. Membership will cost **€100** and entitles the Applicant to one year's Membership. Junior Membership of the Gateway Bowling Club is only available to eligible individuals aged 16 years or under. Membership will cost **€60** and entitles the Applicant to one year's Membership. Gateway Bowling Club reserves the right to require proof of age and identification of the applicant prior to the applicant being considered for membership.

1.2. An Applicant must complete and submit to the Gateway Bowling Club an Application Form, along with the appropriate fee. Membership becomes effective from the time the applicant is accepted by the Gateway Bowling Club as a Member and the applicant's details have been entered into the Club's database. Upon acceptance of the applicant as a Member by the Gateway Bowling Club the Member will be bound by these Terms and Conditions as varied from time to time.

1.3. Membership is granted and maintained at the sole and absolute discretion of the Gateway Bowling Club, and the Club may refuse any application for membership.

1.4. Gateway Bowling Club may at any time, and from time to time, require the Member to produce a specified item or items of identification.

2. Program Benefits

2.1. Membership of the Gateway Bowling Club entitles the Member to free unlimited Gateway Bowling, entry into all Gateway Bowling Competitions and reduced rates on Gateway Mini-Golf at the Gateway Leisureplex for the duration of his or her Membership.

2.2. Gateway Bowling Competitions will be held the first week of every month. An array of prizes will be up for grabs from lots of different Erris based companies. Members will be the ONLY participants who can compete for these prizes.

2.3. Any non-member who bowls with a Member of the Gateway Bowling Club is entitled to half price bowling. Non-members will be allowed to compete in all Gateway Bowling Competitions, but will not be entitled to any prizes no matter where they are placed.

3. Membership Cards

3.1. A person is only entitled to one current Membership, and is permitted only one valid Gateway Bowling Club Membership Card at any time. The Gateway Bowling Club Membership Card remains the property of the Gateway Bowling Club at all times.

3.2. It is the sole responsibility of the Member to safeguard the Membership Card and take precautions against the loss, or any unauthorised use of his or her Card.

3.3. A Member must report the loss or theft of the Membership Card to the Gateway Bowling Club by phone or in person.

3.4. The Gateway Bowling Club may replace a membership card at its discretion, and upon the supply of identification to the satisfaction of the Gateway Bowling Club. The Club reserves the right to charge a fee for the replacement of a membership card. The Club is not responsible for any delay in replacing a stolen card or for any unauthorised use of a card.

4. Suspension and Termination of Membership

4.1. The Gateway Bowling Club may immediately terminate and/or suspend, at the Club's sole discretion, a Gateway Bowling Club Membership without notice for any reason, including, without limitation, if the member

4.1.1. fails to comply with these Terms and Conditions and any variation of them; or

4.1.2. fails to comply with the Terms and Conditions associated with any promotional activity related to the Program; or

4.1.3. acts in a manner which the Gateway Bowling Club considers to be dishonest, offensive, disruptive and/or intimidating to patrons or staff; or

4.1.4. conducts themselves in a manner which the Gateway Bowling Club considers as interfering with or misusing equipment or property; or

4.1.5. at any time has been asked to leave or been excluded from the Gateway Bowling Club; or

4.1.6. at any time supplies misleading information or makes any misrepresentations to the Gateway Bowling Club.

4.2. In the event that membership is revoked or terminated, the Gateway Bowling Club reserves the right to withdraw the Member's Card.

5. Termination of the Program

5.1. The Gateway Bowling Club may suspend the operation of the Program or cease to operate the Program at any time without notice.

6. Privacy

6.1. The Gateway Bowling Club, in the Program Database, will hold information concerning the Member, including information contained in the application form. The Program Database will include the Member's name, address, date of birth, telephone number, email address, identification details and any other information relating to the Member in conjunction with the Program.

6.2. All personal information that you provide to the Gateway Bowling Club is private. The Club will not release personal information to any persons or entities without the Member's explicit consent.

6.3. Members can access their personal information by contacting the Gateway Bowling Club.

7. General

7.1. The Gateway Bowling Club reserves the right to vary the Terms and Conditions at any time without notice.

7.2. The Member agrees to be bound by any variation of the Terms and Conditions. Any amended copy of the Terms and Conditions will be available for inspection at the Club.

7.3. In the event of any inconsistency between any other document brought into existence for the purpose of the Program and these Terms and Conditions, these Terms and Conditions shall prevail.

7.4. All disputes and subsequent decision by the Gateway Bowling Club are final and binding.

7.5. The Gateway Bowling Club accepts no responsibility for any injury, damage or other loss whatsoever incurred by the Member, either directly or indirectly and as a result of any act or omission (including negligence) of the Gateway Bowling Club relating to or arising out of Program, and the Member releases and discharges the Gateway Bowling Club including its employees, agents and contractors and the participating venue from any such liability, damage or loss.

7.6. Any alteration made to Associated Documentation by any person other than the Gateway Bowling Club will have the effect of automatically invalidating that Associated Documentation. Associated Documentation cannot be replaced if such Associated Documentation is lost, stolen, damaged or destroyed, and should be kept in a safe place by the Member.

8. Definitions

8.1. In these Rules unless the context otherwise requires;

8.2. "Application Form" means the Gateway Bowling Club Membership application form;

8.3. "Associated Documentation" means any document arising from the operation of the Gateway Bowling Club;

8.4. "Card" means the Gateway Bowling Club Membership card;

8.5. "Member" is a person who is granted membership pursuant to clause 1.2;

8.6. "Program" means the Gateway Bowling Club Membership;

8.7. "Program Database" means the databases of Member information held by the Gateway Bowling Club;

8.8. "Gateway Bowling Club Membership Card" means a card issued to a Member by the Gateway Bowling Club pursuant to these Terms and Conditions which continues to be valid and which has not been cancelled by the Gateway Bowling Club;

8.9. "Terms and Conditions" means these Terms and Conditions as varied from time to time.
